7. You may not enter the room of another sex, except during supervised activities (devotionals, group meetings etc.)
8. Honor God in everything you do.
9. Learn and have fun.

In order to make events safe and most beneficial for everyone involved, guidelines must be followed. Youth and parents signing this covenant understand that action will be taken by the adult leaders attending this event if set guidelines are broken. These policies are important for all who are members or guests of Collierville United Methodist Church to follow and understand. If these policies are not followed, then the following guidelines are in place to help reinforce positive behavior.

1. Warning for first infraction, unless a major infraction.
2. Youth will be escorted for a time period by adult chaperone.
3. Youth will call home to conference with a parent
4. Youth will be sent home at Parent's expense.
5. Youth will not be allowed on next outing.
